

Course registration instructions

- Dealing with CDWS will be directly with facilities that are a CDWS' member and licensed by the Ministry of Tourism only, and will not deal directly with the Boat's crew.
- The facilities that are CDWS' members and licensed by the Ministry of Tourism, will be entitled to participate in the courses according to the mentioned targeted categories. Please refer to the above. (Please send a message includes the text "Excel Sheet" on WhatsApp service # 01203888582) in order to send to you the Excel Sheet, after filling all the required data for the participants, re-sent the Excel Sheet via e-mail to training@cdws.travel.
(If the data is not completed as required, the table will not be accepted).
- A copy of the national ID card must be attached for all participants whose names are registered with the file sent from the establishment (face and back) so that all card images are in one PDF file.
- In the event that a facility needs to make an amendment either by deleting or adding to any of the data already sent to the CDWS, the technical manager should highlight and shade the modified part, with clarifying the reason and re-send it again.
- The CDWS; will match the sent photos of the participants attached ID with to the sent tables to verify the accuracy and conformity of the sent data.
(In case of non-conformity, the application will not be accepted and the applications will not be processed).
- Please note that each participant is entitled to attend only one session.

Rules and regulations for the attendees during the courses

- To attend at least 45 minutes before the session in order to confirm your registration with your ID card.
- To comply with the instructions of the lecturer until the end of the course.
- To attend the entire session from the start till the end.
- Food and drinks are prohibited inside course premises.
- Put the mobile phones on silent mode to save your times and to ensure the completion of the course properly.
- In case of violation of any of the instructions, the violator will not be allowed to enter or to complete the course; accordingly, the CDWS' card will not be issued in order to work on Safai Boats.
- Adherence to the precautionary procedures for Covid-19 (Wearing a face mask / repeatedly disinfecting your hands / Keep a safe distance at least 1 meter between attendees)

Instructions should be applied after completing the course

- After completing the courses, the technical managers of the facility or the legal representatives should apply to the CDWS in order to issue CDWS' cards for their safari boats' crews, who attended the course, and to issue and pay 150 EGP per card for the new CDWS' card. Please note that CDWS will not deal with the crews directly and the facility that is CDWS' member should coordinate in this regard.

- The annual cost for issuing or renewing CDWS' card is 150 EGP.
- The facilities may not permit anyone to work on board of safari boats; except after attending the mentioned courses and extracting the necessary CDWS' card.
- The Ministry of Tourism and the Chamber shall coordinate with the concerned security authorities not to allow boats to leave unless they have committed to participate in the course and obtain the Chamber card. Note that the Ministry of Tourism and the CDWS is in coordination with the concerned security authorities will not allow the yachts to work before the commitment of participating in the session and get the CDWS' card.
- The boats' crews should not work on the non-authorized boats by the Ministry of Tourism and non-members in CDWS. In case of violation, the CDWS' Card will be taken and the violators will be suspended.
